MEETING MINUTES

June 20, 2023, Meeting

The Grady County Board of Commissioners met on June 20, 2023, at 6:00 pm for a regular meeting. Commissioners LaFaye Copeland, Ray Prince, June Knight, Keith Moye, Phillip Drew, County Administrator Buddy Johnson, County Clerk John White, County Finance Director Holly Murkerson, County Attorney Gabe Ridley, and Road Superintendent Stanley Elkins were present.

Mr. Drew opened the meeting with the invocation and pledge to the flag.

Public Hearing:

Mr. Drew opened the public meeting on the Vehicle Decal Resolution and review the rules for the public hearing.

Michael Cook, 184 Carr St Calvary, Ga

Urge to vote no on the vehicle decal. Vinyl decals can be safe to the paint of vehicle. He referenced the law. Clear to exempt the County Administrator and County Road Superintendent. Undermines the pride of the county.

Yancey Maxwell,

Has three things to say. Have symbols and have pride in our vehicles and have emblems on our vehicle. Need some pride put back. Need symbol on the truck.

Mike Bishop, Cairo, GA

Asked how decals will be put on lease law enforcement vehicle. Puts decals on his corvette for car parades with no damage. Need decals on county vehicles.

Mr. Johnson stated that Mr. Bishop is correct on patrol vehicles.

Terry Akridge, 111 Wood Duck Dr

He is not sure why there is such heartburn over decals on vehicles. He stated that it is an attack on Mr. Johnson.

Kelly Kennett, Cairo, GA

Looking at \$4,000.00 to mark cars. She would rather that money be spent on Recreational opportunities for our children.

Robert Humphries, Roberta Rd

All County Vehicles and equipment should be marked for safety reasons for citizens and employees.

Donald Evans 2136 Hwy 111 S

Is a county vehicle a commercial vehicle? There is not an issue with the label coming off. Want people to see me. If ride by his place, want to see the truck at Buddy's place. Spoke with several leasing companies today and they stated it does not lower value.

Rick Kines, Cairo

Been in government for 48 years. Had good commissioners and bad commissioners. Why do you want to reinvent the wheel. Why not pay Buddy a stipend for vehicle use. Need to take pride. Do your job.

Jimmy Johnson, Grady County

Gets the idea that the board has already made up their mind. Do what the people want. Listen to what the people want.

Debbie Johnson, 1202 Sutton Mill Road

We drive really nasty oil trucks. Why Mr. Johnson feels the way he does.

Mr. Johnson stated that Enterprise does say it matters. We lease the vehicle wholesale and then after one year, Enterprise sells them at retail. Enterprise then gives the money back to the lease for the county. The last two trucks, the county made \$12,000 per truck that goes back to the lease. Mr. Johnson stated it is wrong to say he has no pride.

Sam Carline, Cairo, GA

Mr. Carline stated that he buys lots of vehicles from Enterprise and they are allowed to put them on the vehicles.

Vehicles need decals.

Asked question that what is the penalty for not marking vehicles? There is no penalty listed in the law.

Mr. Drew then closed the meeting.

Motion by Mr. Moye, second by Mrs. Knight to amend the agenda by adding FA044-23 naming Maura Elkins as Assistant EMA Director. The motion was approved. Later in the meeting, there was a motion by Mr. Prince, second by Mrs. Copeland to amend the agenda again by adding FA045-23 which was to pay Mr. Johnson a stipend of \$600.00 per month for travel expenses. The motion was approved.

Did not call and ask Mr. Rawls if he wanted to continue to serve. No one cared enough to make a phone call. Mr. Rawls was hired as chief appraiser in 1973 and was in the position for 27 years. Then retired in 2000 and was then on the Assessor's board. He had been there 50 years. You are losing 50 years of experience getting him off the board. The Commissioners are in charge, and you are responsible for the actions. Sometimes you are a rubber stamp for the administrator.

Mrs. Copeland stated that she did not know about Mr. Julian until the day she came to the meeting and saw Mr. Cannington's name on the paper (agenda). She assumed that Mr. Rawls had resigned. She apologizes for that mistake.
